Shipping Information: Shipping will be either by UPS or motorized ground freight. Shipping costs are based on purchaser's time zone and must be added per case or per single unit to the order total. Any orders requiring motorized ground freight will be invoiced for all shipping charges. Final method of shipment will be the most economical means determined by the number of cases ordered. All pricing subject to change. Orders must ship to a street address, not a P.O. Box.

Sales Tax: Tennessee residents add 9.25% state sales tax to the final order total. If purchaser is eligible for tax exemption, the Appropriate tax exemption form and I.D. number must be submitted to JOSHCO, LLC when the initial order is placed.

TIPS FOR ORDERING

Here are some tips that should be helpful as you consider your order and complete your order form.

Make copies of the original order form from the other side of this sheet and use these copies for your orders. Keep the original form in a safe place and make additional copies as necessary. Only one copy of the order form is now required when submitting your order.

Complete all areas of the information that pertain to your purchase. It is important to provide a telephone number for the shipping address being used. It is also important that the shipping address is a street address and not a post office box. UPS can not deliver to post office boxes.

If you have a fax number or an e-mail address, please provide them in the appropriate spaces. This will allow for a quick confirmation of your order once it has been received.

Always include your unit / post name and number. This will assure proper credit of your purchase for your state.

When ordering with a credit card be sure to circle the form for either MasterCard or Visa. Also make sure that the mailing address shown on the order form is the same as the billing address for the credit card. It is all right if the shipping address is different from the mailing address, but the mailing address must match the credit card's billing address.

Due to increases in shipping costs from UPS it will now be necessary to add shipping charges to all orders. Effective September 1, 2000, all single-unit orders will add \$4.00 per unit for shipping. All case orders will add \$9.00 per case for shipping.

Only Tennessee residents and any orders shipping to a Tennessee address will need to have 8.25% sales tax added to the order's final total. This total includes all units purchased plus shipping costs.
