#### **HIGHLIGHT OUR HEROES**

**Scott Bradley Anderson, Sgt. US Army served in Vietnam.** He was a member of Boyceville Post 314. Scott joined the Army with the encouragement of a classmate before he graduated High School in 1972. After basic training, he told his dad he wanted to be a paratrooper. His dad asked him if they make more money, Scott told him yes, they do. Then his dad said I guess you are a paratrooper. He married a local gal and took over the family farm. From pickles to watermelon, he always did things in a big way, like 150 watermelons that required taste testing. He was very organized and was the glue that held Post 314 together. Even when fighting cancer, he set up honor guards, organized Memorial Day ceremony as well as speaking at school events. Scott was very community minded. Him and his wife Connie acquired a military jeep, restored it and drove it in parades, and events to honor the military. His son drove the jeep to Scott's funeral. Scott loved his family, his country and being a farmer. We salute Scott Anderson!

**Roman "Butch" A. Sabota Sgt. US Army Air Force,** from Independence Post 186. Butch Sabota was inducted in the service in 1943, following basic training he went to Aerial Gunnery School in El Paso Texas. During this time, he spent a month as an athletic instructor, because of his knowledge of team sports. In December 1944, two months after Butch arrived in England and less then one month prior to his 21<sup>st</sup> birthday, the 392<sup>nd</sup> Bomb Group's mission #216 began. 29 aircraft began launching for the railroad yards in Kaiserslautern Germany. Over the target, 500-pound bombs were released. After two minutes of releasing bombs Stg. Sabota's aircraft was struck by German fighter aircraft, number two engine caught on fire, and soon the bomber exploded. Prior to the explosion, six parachutes were observed to have opened, one of them carrying Butch Sabota. After bailing from his stricken aircraft, Butch was captured near Muenchweiler Germany. He was relieved to be captured by the German soldiers, for fear the local with pitch forks would kill him. He spent five months until the end of the war in a Germany prisoner of war camp located on the Baltic coast. On May 1<sup>st</sup>, 1945, he was liberated by the advancing Russian Army. His mother received a western union telegraph stating that he was missing in action, followed by another telegraph stating that Butch was a prisoner of war. In 1945 he boarded a ship and headed back to the United States and he was Honorable Discharged. He was awarded the following: American Theater Ribbon, European – African Middle East Ribbon, one Battle Star, WW11 Victory Medal a special POW medal authorized by an Act of Congress. After the war Butch's dog tags were found in Germany and sent to the Smithsonian for display. **We salute Roman "Butch" Sabota**!

#### MEMBERSHIP MESSAGE FROM ALA DISTRICT CHAIRMAN TERESA STEINKE

Spring is in the air—I have been watching the robins fluttering around our yard for nearly a month now—and yes, they have now had snow fall on their tails three times, so we should see spring weather soon (an old tale by the "old folks", who used to say that the robins had to have snow on their tail feathers thrice before spring would arrive ;) With Spring in the air, it is now time to come out of hibernation and begin work on our programs again—especially to engage with our members who have allowed their membership to lapse—and to reach out to potential new members! Balto is lagging way behind the pack, in 11th place.

I am amazed with the progress that some of the Units in our District are doing: According to the last Membership Report, the following Units have reached their goals: Eleva, in Trempealeau County, is really reaching for the stars with a whopping 117,86%. Congratulations to President Robin Rasmussen and her entire team, which includes every single member in the Unit! You are doing a fantastic job—well done indeed! Second and third place units are also from Trempealeau County are Independence, with 104.76% and Osseo, with 101.41%. Kudos to President Debbie Kampa from Independence and President Sherry Brasda from Osseo, along with their entire units on their outstanding accomplishments. Rounding out the units who have already reached their Membership Goal is Brackett, in Eau Claire County. President Brenda McMahon and the members in this unit have achieved 100% of their goal.

We do have several units throughout the District who have renewed every member from the previous year, and I am so very proud of each of you as well. I understand your frustration that, even though you have renewed all of last year's members, you have not met your Membership Goal, which was set by National. Sadly, we know that many of our units have lost members, simply because they have passed away. Other members from a previous year may have moved away or have chosen to not renew for various reasons. Those members were part of the equation when National set those Membership Goals. Why, you ask? Because we still need members, and if those members are no longer in this vital organization, then we need to find new members so that we are able to carry on the work that we do for our veterans, our children, our communities and our nation! To each of you, who fall into this category. I would like to suggest a couple of action plans:

**First,** reach out to all of your previous members, by doing a Poppy up call. Ask them how they are doing, let them know that you have been thinking of them and that you have missed them in your organization. Ask them if there is a reason that they dropped their membership, listen to their concerns, give them validation, and then try to encourage them to rejoin. In the case of a deceased member, perhaps there are other members of the family who would qualify for membership. Give them an overview of the ALA and invite them to join!

**Second,** as you are going about your daily life, listen for opportunities to share with others the extremely important work that we do within our organization, and invite those who qualify to join us! I always try to have several American Legion Family application tri-fold pamphlets with me, so that I am able to hand one to someone who may be eligible to join.

Third, do you have a community event coming up in your town or county? Ask if you would be allowed to set up a membership table—and recruit for the entire American Legion Family! More and more—especially younger— families have limited time, so they would prefer to do things together, as a family. Portray the American Legion Family as just that! If we want to attract those younger members, we need to meet them where they are at—and this is our opportunity to do so!

Now, we also have some units who are struggling with renewing last year's members. I would encourage each of you to also look at the suggestions that I provided above. I calculated that if each of the units who have not renewed last year's members would just do that, we would catapult from 11th place in the Department of Wisconsin into a very strong 1st place! If you need help, please reach out to me—I will help you as much as I can!

I look forward to seeing many of you at the Spring Conference, where I will be distributing several awards and discussing how to overcome the challenges of membership.
