### CONGRESS

The Senate met on Tuesday and elected Sen. Murray (D-WA) as President pro tempore. She is the first woman to hold that position. Sen. Schumer (D-NY) continues as the Majority Leader, and Sen. McConnell (R-KY) is the Minority Leader. McConnell is now the longest serving Senate leader, beating the record of Sen. Mansfield (D-MT) who served as Majority Leader for 16 years until his 1977 retirement. The Chamber then adjourned, except for pro forma sessions, until January 23, when the real work will begin.

The House is starting the 118th Congress much less smoothly. Between Tuesday and Thursday, Rep. McCarthy (R-CA) failed to achieve sufficient votes to become Speaker of the House on eleven tries. In fact, Democratic leader Rep. Jeffries (D-NY) got more votes on each ballot (212) than McCarthy achieved each time, due to a group of 20 Republican holdouts. Rep. Donalds (R-FL) has come forward as the leading challenger to McCarthy on the Republican side of the aisle, although he only received a handful of votes each time.

Due to the slim Republican majority, McCarthy can only afford to lose four Republican votes in order to clinch the Speaker position. Among the 20 Republican opponents, some are seeking more concessions while several (probably more than five) simply do not like or trust McCarthy and are unlikely to support him regardless of concessions. McCarthy appears determined to continue holding votes and negotiating away concessions until he is elected. His supporters, as of Thursday morning, started muttering to reporters their doubts on the wisdom of this approach.

McCarthy has reportedly offered up significant concessions. One would include in the House rules the ability for a single Member to call for the Speaker to be removed, which would leave McCarthy on incredibly shaky political ground. Other concessions would allow individual holdouts to assume subcommittee chairs for which they would not otherwise be considered.

### WHAT DOES THE HOUSE CHAOS MEAN?

The House cannot operate until there is a Speaker in place. The Members cannot even be sworn in. Committees will not know how many members of each Party they will have, and staff cannot get paid. In fact, there are no specific rules in place, which has made some of the floor Speaker debates murky.

Staff has told reporters that their requests to Executive Branch agencies to help constituents are being delayed. One letter, from the IRS, said the agency could not help because the Member was technically only a Member-elect, as no one has been sworn in.

Members involved in oversight of the military and intelligence community routinely receive briefings of secure and secret information. Currently, those Members' security clearances have been paused, briefings are not occurring, and the lawmakers cannot even access the sensitive compartmented information facility (SCIF) located in the Capitol.
