


#### BRUNCLIK-KNOOP HAUGEN DONATION TO BARRON COUNTY VSO

The American Legion Auxiliary Brunclik-Konop Haugen Unit 0540 donated \$6,000 to the Barron County Veterans Service Office at its Feb. 26 meeting at the Haugen Village Hall. The funds are to be distributed to veterans in need.

The auxiliary raised the amount through kolache sales and raffle basket sales during Haugen Fun Days last August.

Accepting the generous donation were Barron County Veterans Service Officer Scott Bachowski and assistant VSO Shellie Shaw. While accepting the funds, Bachowski said, "Shellie and I truly appreciate the dedicated fundraising efforts the Haugen American Legion Auxiliary does every year. Every year since 2012, they have donated funds toward the Barron County Veteran Aid Fund. "These funds are available to veterans that are in a temporary financial crisis. With these funds, we have been able to provide financial aid to hundreds of veterans. The financial aid provided to veterans gets delivered in many ways such as gas and grocery cards, rent and security deposits, vehicle repairs, motel stays, clothing, school supplies and job tools. Without these donated funds, we would not be able to help as much as we have been fortunate to supply since 2012, "Bachowski said "Shellie and I are simply the conduits to disperse these funds – the true heroes are the members of the auxiliary. We thank them with all of our hearts. We notice the pride and happiness that beams from their faces when they present us with the check. We can see their joy knowing they can turn a bad situation into relief for our veterans.
